1. Call to Order

At 9:30 a.m., Jamie Macfarlane, the Chair, called to Public Hearing to order the January 19, 2023, Maricopa HOME Consortium Public Hearing held virtually.

Jamie Macfarlane stated the Public Hearing was open to the public for comments regarding the upcoming draft of 2023-2024 Action Plan regarding HUD Grants. She informed the committee that no comments from the public were received via email or mail prior to the meeting. She called for any members of the public in attendance to speak. Alan Bermudez asked if Avondale was a part of the Consortium and received a positive answer.

The Public Hearing was closed, and the Public Meeting was called to order at 9:36 a.m.

3. Staff Updates

Jamie Macfarlane introduced new staff members, Wendy Johnson and Carson Folk. Wendy is the integration Coordinator who will be taking us through the Con Plan, CAPER, and Annual Action plan as well as monitoring and related tasks. Carson is the affordable housing coordinator who will be working with all of the ARPA funded projects. There are several key positions open: Home Coordinator, Grants Specialist and an Management Assistant. Carl Eastin is transition to be the CDBG coordinator.

4. Approval of Minutes

7. Collaborative Funding Workgroup update

Jamie Macfarlane shared that there was a casual meeting in December for the Collaborative Funding Workgroup. Starting in February 2023, there will be an hour-long Collaborative Funding Workgroup meeting immediately following the HOME Consortium meeting. Additional discussion was held around procurements, which will be a part of the Collective Funding Workgroup.

8. Roundtable Discussion

Consortium members gave updates for their cities/town on their HOME activities and staffing.

9. Call to Public

Alan Bermudez spoke to his desire to see the Hispanic Community to receive better education and access to Fair Housing Training.

10. Adjournment

There being no other business, the Chair entertained a motion for adjournment by Karin Bishop. City of Chandler and seconded by Trilese DiLeo, City of Glendale. The vote was called and the motion passed unanimously. The meeting was adjourned at approximately 10:38 a.m.
